MINK MISSOURI RIVER CORRIDOR, INC. MISSOURI, IOWA, NEBRASKA, KANSAS

The MINK corridor includes rural counties in the four-state region from south of Omaha, Nebraska, to just north of Kansas City, Missouri.

HOW WAS MINK ESTABLISHED?

- MINK was licensed as a 501(c) (6) in 2013 in all four states.
- It structured itself as a membership, dues-paying organization and has since established standing committees.
- The mink corridor was designated a "Great Region" in 2013 by USDA-Rural Development for working in regional development.
- MINK is located within the M-29 Marine Transportation Corridor that was established in September 2013.



STRATEGIC PLANNING WORKSHOP

- Funded through a USDA-NIFA special needs grant
- Strategic planning in the fifty-mile corridor on each side of the Missouri River crosses many local community, county and state boundaries.



- Extension professionals from four states, through their access to research-based information systems, will lead a two-day retreat for MINK members and other representatives from within the MINK Corridor.

MISSION: MINK Missouri River Corridor, Inc. works as a multistate collaboration to leverage resources and spark new investments to support growth and opportunity for rural communities in the areas of housing, entrepreneurship, transportation, and tourism to reverse the downward economic and demographic trends.

• We value **decision making through consensus** based on facts in order to achieve the highest potential for positive impacts; so, we will work in a fair and transparent manner and be diligent to provide timely information, opportunities for open interaction, and effective reporting mechanisms.

As a result of the November 2014 Strategic Planning Conference:



- MINK is moving forward in a unified effort
- Committees are now working to identify specific projects
- MINK Board members are working to create partnerships that will support future projects that are identified by the working committees.

STEPS TOWARD SUCCESS

- The transportation committee identified development of the St. Joseph port on the Missouri River as a priority.
- They are now moving forward to approach MO USDA-RD director for re-classification of the port site from "urban" classification to "rural" port which would make it eligible for USDA-RD funds.
- They have contacted legislators and have the support of both US Senators from MO as well as two US Representatives from MO and one US Representative from KS.
- The local USDA-RD office is assisting in these efforts.

PARTICIPANT COMMENTS

Focus on providing tangible outcomes. We've been plowing the same ground over and over (meeting and planning). Now MINK needs to plant seeds and cultivate. Plant so we can start to see some fruit.
