# **NIFA Update**

- 2. Sec. Perdue announced on 9 August that NIFA and ERS would be relocated and possibly collocated before the end of 2019. A notice soliciting relocation inquiries from interested entities was posted in the Federal Register.
- 3. The FY19 House and Senate proposed budgets both have the RRDCs in at \$2M (split between the four Centers).
- 4. The RRDC directors in DC 6-7 September. The robust agenda includes sessions with Acting NIFA Director, REE Congressional Affairs, ECOP, Consumer Financial Protection Bureau, Rural Opportunity Initiative, Institute of Museum and Library Services, USDA Rural Development, USDA Farm Service Agency (FSA), and USDA Office of Partnerships and Public Engagement (OPPE).
- 5. The latter two meetings with FSA and OPPE are to kick off new Interagency Collaborations that include NIFA, the RRDCs, Land-grant partners, and Cooperative Extension.
  - a. In collaboration with FSA, the Farm Stress Employee Training and Technical Assistance (FSE-TTA) will be led by the North Central Region to develop training, resources, and outreach materials that will support FSA field employees as they serve farmers and ranchers under stress.
  - b. In collaboration with OPPE, the Partnership and Community Collaboration Training Summits (PCCTS) will be led by the SRDC to convene six regionally based trainings for field-based USDA staff to improve customer engagement, maximize efficiency, and improve agency collaboration. More details on both initiatives will be forthcoming after the September DC meetings.
- 6. The Enhancing Agricultural Opportunities for Military Veterans (AGVETS) FY18 RFA will post mid-October.
- 7. The SRDC TOAC/Board will convene their annual meeting in Arlington, VA on October 23-25.

## **Recognition (Awards) Committee Update**

The Awards Committee met via Zoom, August 16, 2018. While not every member could participate, five members as well as the committee liaison took time to review all the current awards. M. Dougherty presented a historical perspective, while R. Wellborn presented a reviewer's perspective or the current awards.

Three critical issues surfaced in the discussion. There was consensus among the committee members participating in the Zoom that the criteria for evaluation for most awards needs clarified and scoring realigned to reflect the most important criteria. Also more emphasis needs to be placed on uniqueness of program or effort, along with sustainability or renewability that ultimately leads to a greater impact. There was much discussion around page limits for items like letters of support, as well as requiring one document format for award submissions.

The committee discussed a better process for submissions for the Distinguished Career Award. This along with other changes will be submitted to the NACDEP Board for consideration in October.

The last item discussed was how to reference the new JCEP award. The committee would like the NACDEP Board to decide on the verbiage. With some minor revision the current Innovation and Creativity Award serves the same purpose as the JCEP award. However, with JCEP funds attached to this award, the group sees it as being elevated and wants to make sure that JCEP receives recognition.

The committee's immediate action item for the NACDEP Board is: Should the award be retitled as the JCEP Creative Excellence Award? Or leave the title the same, NACDEP Innovation and Creativity Award and perhaps add Sponsored by JCEP? Or is there another alternative the Board would like the Awards Committee to explore?
